Please find enclosed the Initial Consultation information for your review and comment regarding the following application:

**CUP22-0014/PD-R22-0004 – SIENNA RIDGE QUICK QUACK CAR WASH (Quick Quack Car Wash Holdings, LLC/Donahue Schriber Realty Group, L.P./CRM Architects & Planners, Inc.-Bruce LaRose):** A Conditional Use Permit and Planned Development Revision requesting the development and ongoing operation of an approximately 3596-square-foot automatic Quick Quack Car Wash. The car wash facilities would gain entrance from an encroachment onto Sienna Ridge Drive and includes a secondary encroachment onto Bass Lake Road. The site will include associated parking, vacuum accessible parking, waste disposal area, landscaping and outdoor lighting. The property, identified by Assessor's Parcel Number 123-570-016, consists of 1.59 acres, and is located on the west side of Sienna Ridge Road, approximately 800 feet south of the intersection with Bass Lake Road, **in the El Dorado Hills area, Supervisorial District 1.**

Pursuant to Section 15063 of the State CEQA Guidelines, this Initial Consultation is being conducted to determine if the project may have a significant effect on the environment and determine whether an environmental impact report or a negative declaration will be prepared.

Review and comment by your agency is requested to identify your concerns to be considered by the County during our environmental review to mitigate impacts, develop conditions of approval, and/or modify the project. Your agency's written responses must be received by the Planning Services **no later than February 9, 2023.** If we do not receive written correspondence from your agency by that date, we will assume your agency has no comment and your agency's concerns may not be reflected in our recommendations.

**The Technical Advisory Committee (TAC) will meet on February 20, 2023,** to take one or more of the following actions; 1) Make an environmental determination, 2) Identify additional information needs; 3) Determine final project conditions and/or, 4) Confirm the public hearing date. TAC Meetings are currently being held remotely via Zoom only (no physical meeting location). County Planners processing agendized applications organize individual TAC meetings.
