If no such analysis is required, please provide a copy of their determination letter/waiver. County AQMD can be reached at (530) 621-7501. *Checklist item No. 20.*
- 3. A completed **signed** Oak Resources Code Compliance Certificate (enclosed). If any Oak Trees or Oak Woodland will be impacted, please provide the information listed in items 2-5 in the Oak Tree/Oak Woodland Removal checklist section. *Oak Tree checklist item no. 1 under Oak Tree/Oak Woodland Removal*. See attached.

4. Please include the dimensions for all parcel lines on site plans. Site Plan Requirements Checklist item No. 4.
